Atlee Dodge Drawing List 2089, dated March 15, 1989, or later FAA approved revision, and installed per F. Atlee Dodge Installation Instructions Drawing 2089-18, dated 2-22-89, or later FAA approved revision.

### Limitations and Conditions:

The seaplane versions of the PA-18 and PA-19 are eligible for the safety cable kit installation when operating as landplanes with the standard PA-18 landing gear installed.

Limitations and Conditions: (Continued)

The approval of this change in type design applies basically to Piper Model PA-18 and PA-19 airplanes only. This approval should not be extended to other aircraft of these models on which other previously approved modifications are incorporated unless it is determined by the installer that the interrelationship between this change and any of those other previously approved modifications will introduce no adverse effect upon the airworthiness of the aircraft. This determination should include consideration of significant change in weight distribution such as an increase in the fixed disposable weight in the fuselage.
